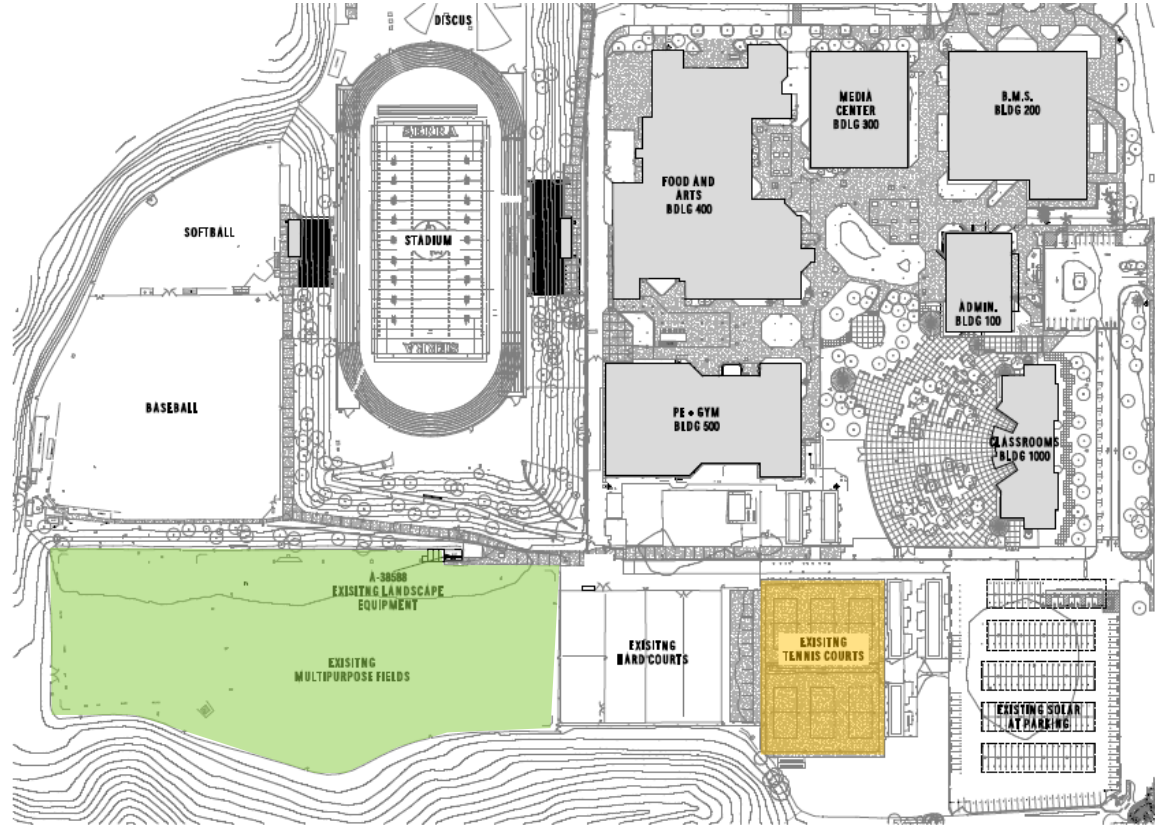

## Previous Joint Use Area

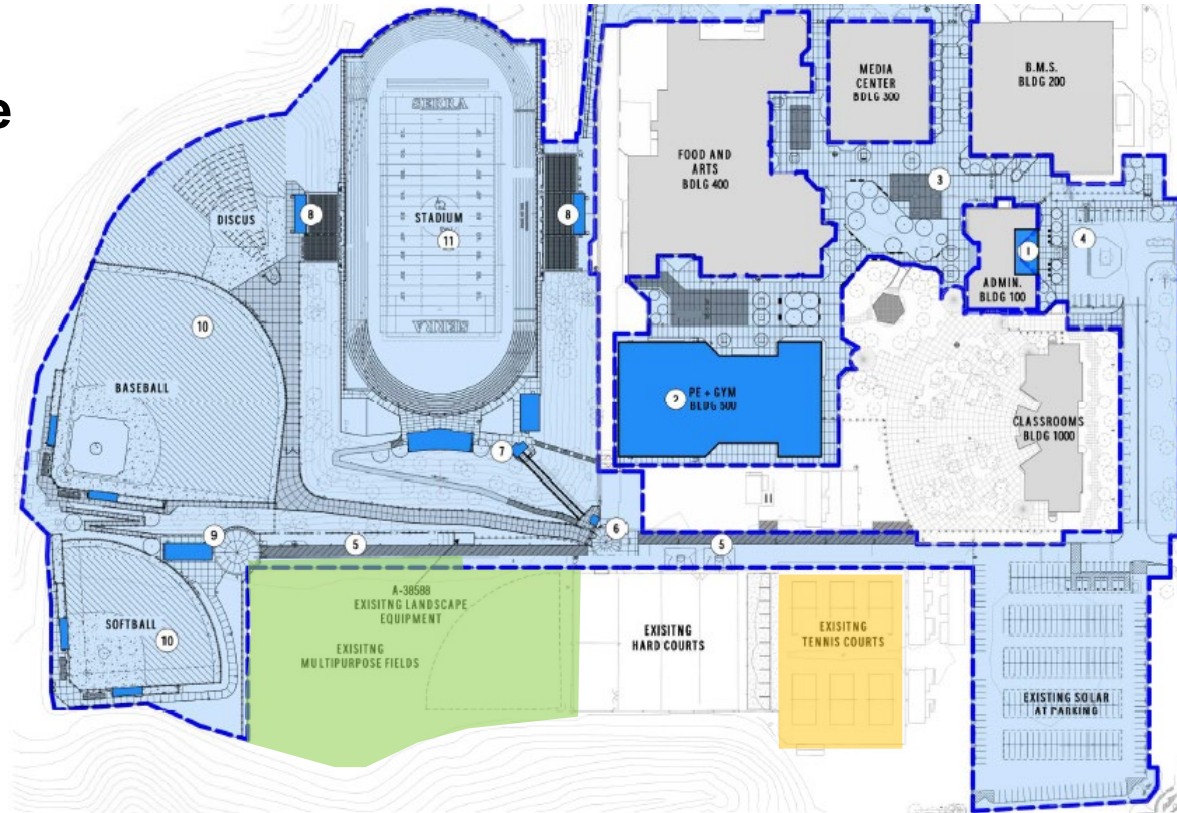
- 4.71 acres of natural turf

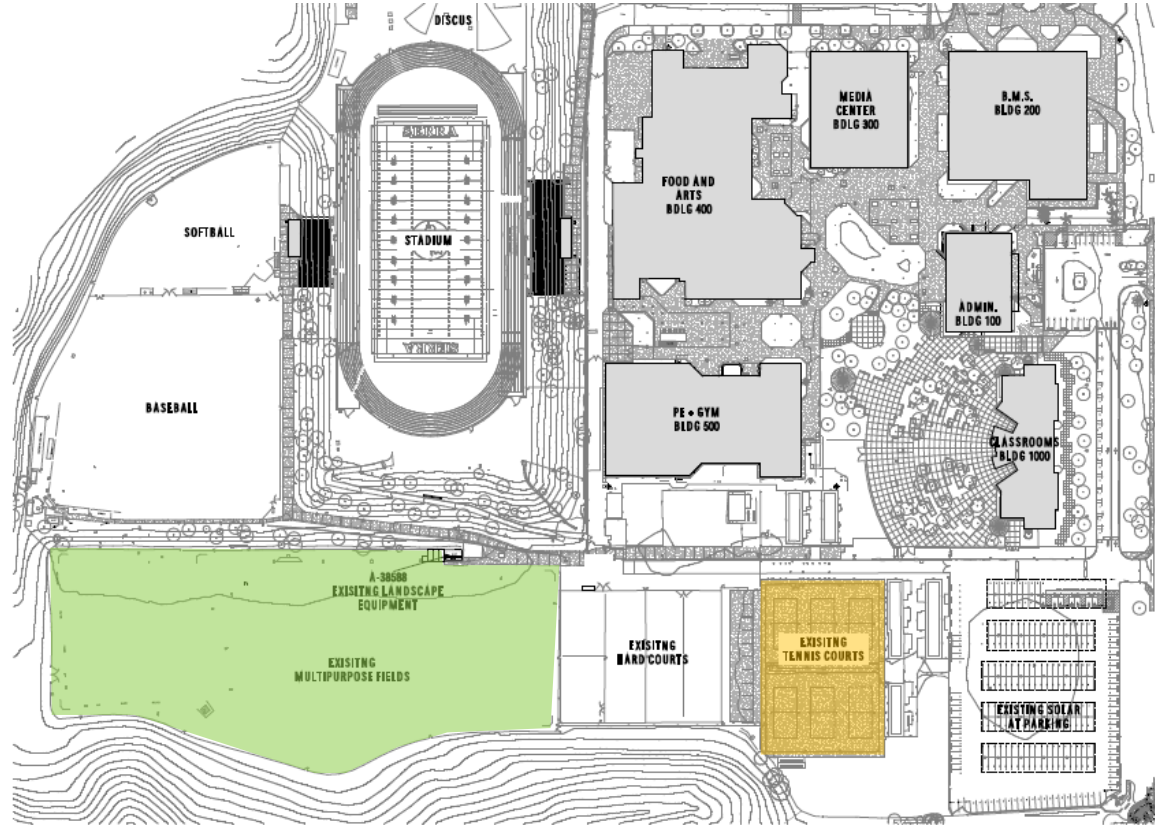

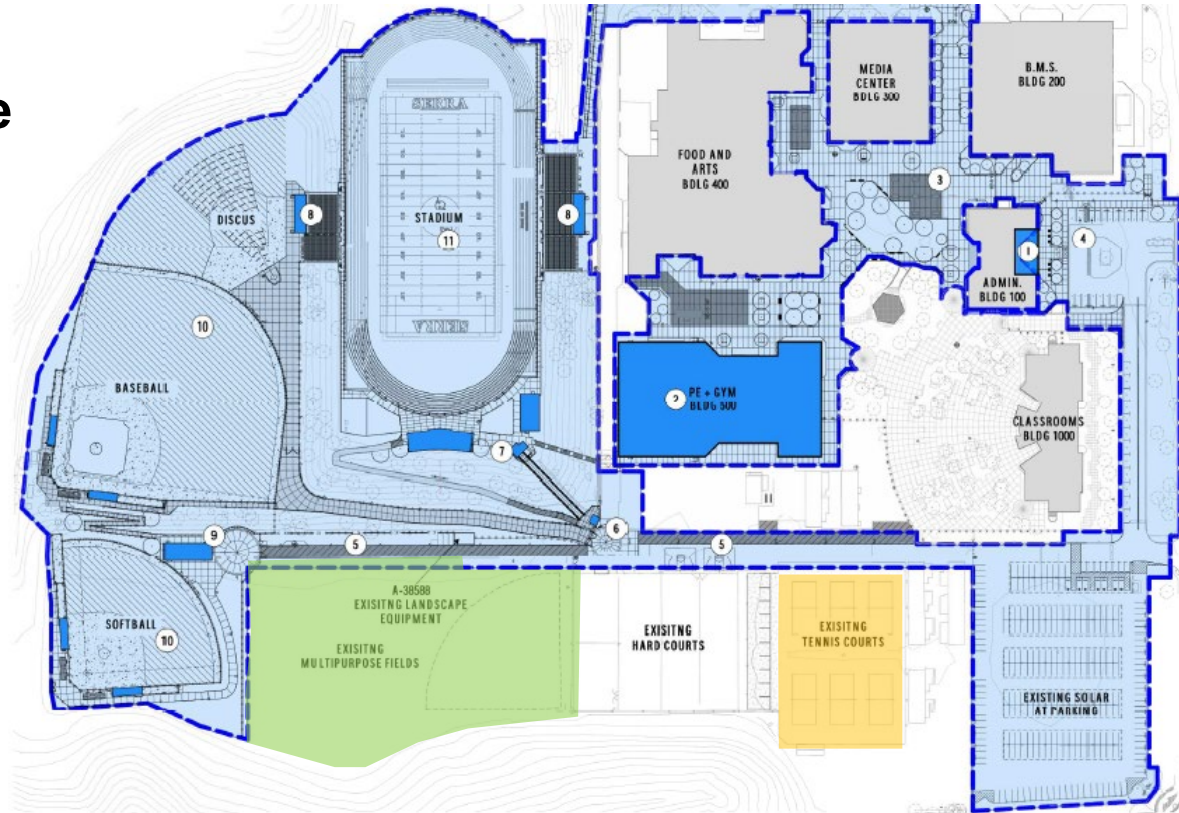
